

CASTLE ROCK TOWNSHIP
Annual Road Inspection
May 20, 1999

The Annual Road Inspection was convened at the town hall at 6:00 PM, May 20, 1999.

Present were Norbert Kuhn Jr., Vice-Chairman, Jim Ozmun, Ken Betzold, Bill Neil, Supervisors, Michelle Nicolai, Clerk, Mark Henry, Mark Wagenknecht, Elaine Wikstrom, Frank Gerdesmier and Jim Bell, Road Committee.

- 1.) 240th and Biscayne Ave. - Put aprons on the culvert to widen the road.
- 2.) Between 240th and 250th on Biscayne Ave. - There is a 6 to 8 foot deep washout flowing out of culvert. Recommendations to put up railings for safety.
- 3.) 250th - NO, this is a county project.
- 4.) 240th - 1/4th mile West of Hwy 3, culvert is buried and plugged.
- 5.) Denmark - 1/4th mile South of 240th to 250th needs gravel and road is too wide.
- 6.) 280th and Delft in the city - pothole and crack in the pavement.
- 7.) 278th and Danville - pothole and crack in the pavement.
- 8.) 263rd - Rocky Hills, pavement cracks and rises over the culverts. 263rd East of Canada needs overlay.
- 9.) 264th St.W. and Canada Ave. - work was done last year on the pavement and it held up well, James Johnson said the fracture pothole can be fixed with infra red.
- 10.) Cambodia and Northeast corner of Neilson property - No ditch left.
- 11.) 277th and Biscayne Ave. - King Castles, 10 to 12 trees need to be cut down, across the street from Jim and Vera Hood 2345-277th and next door to 2280-270th.
- 12.) 270th between Akron and Blaine - Clean out silt from culverts.
- 13.) 270th - Ditch problems. Gravel from Blaine to 47.
- 14.) 250th - Gravel 1 mile by Bill Mays and put in tile.
- 15.) 232nd - Gravel specs have a lot of sand and the rock size will not meet specs.
- 16.) 230th between Audrey and Blaine East of the bridge - Spray the brush.
- 17.) Annette Ave.- Gravel.
- 18.) Beaumont Way and Beaumont Ave.- Cracks in pavement. Mr. Gerdesmier felt that once it warms up the pavement will expand and we should not worry about it.
- 19.) 230th between Alverno and Biscayne Ave.- Clean out ditches and gravel first half mile East of Biscayne..

A motion was made by Bill Neil, seconded by Ken Betzold to adjourn at 9:15 p.m. Motion carried.
