**APPROVE REGULAR MEETING MINUTES**

**Bill Neil made a motion and Randy Becker seconded to accept and approve the minutes of the June 12, 2002 regular Board of Supervisors meeting as written. Motion carried 5 ayes.**

**APPROVE ROAD INSPECTION MINUTES**

**Randy Becker made a motion and Jim Ozmun seconded to accept and approve the minutes of the July 2, 2001 road inspection minutes as written. Motion carried 5 ayes.**

**VIKING SALVAGE BUILDING PLANS**

Discussion was held of the concerns with Building Official about plans. Ron Wasmund faxed a copy of his concerns with the plans. The Board discussed these with Buford Faust who was present and are underlined on copy attached to these minutes. **Jim Ozmun made a motion and Doug Wiedder seconded to approve the building permit contingent upon the applicant and the building official working out the building code issues prior to release of the permit. **Randy Becker made a motion and Doug Wiedder seconded to approve the building permit of Mark Tutewohl 4244 220<sup>th</sup> street west, Farmington to build a manufactured home. Motion carried 5 ayes.**

#### **JAMES ELVESTAD PERMIT**

Discussion was held regarding James Elvestad removing house and he had called June 26, 2001 informing the clerk that there would be a delay and the fire department would burn it in September. **Jim Ozmun made a motion and Bill Neil seconded that the Township would extend the permit and hold the bond until the project is completed. Motion carried 5 ayes.**

The letter from Kimber was read and the Clerk was advised to contact the Township's attorney and get an easement agreement made that the responsibility to maintain tile would be belong to the Township and repair must be done the Township will be responsible for damage done to crops.

#### **UNLICENSED CARS**

The clerk will give the list of owners of unlicensed cars to Board members and they will check to see if the owners are compliance with the ordinance. If not, names will be bought back to Clerk and more notices in the form of a letter will be sent to take care of the problems of unlicensed cars.
