

**CASTLE ROCK TOWNSHIP  
BOARD OF SUPERVISORS RECONVENED MEETING  
March 27, 2007**

The reconvened meeting of the Board of Supervisors of Castle Rock Township was convened at the Town Hall on Tuesday, March 27, 2007 at 8:00 p.m. Present were Russell Zellmer Chair, Arlyn Lamb Vice Chair, Mike Rademacher, Gary Piphon, Michael Kiefer Supervisors, and Maralee Rother Clerk. Russell Zellmer Chair called the meeting to order at 8:00 p.m. and the Pledge of Allegiance was recited.

The purpose of this meeting is to reconvene the recessed meeting of Tuesday, March 21, 2007 to review the building permit for Tom and Cheri Tate, response to Minnesota Department of Human Services, review the list of concerns compiled by Gary Piphon and Arlyn Lamb regarding Fountain Valley Comprehensive Plan and rules for collecting delinquent accounts receivable.

**HUMAN SERVICES-HAVEN DISCUSSION**

Michael Kiefer read statute 462.357. Michael Kiefer asked the Board if they would listen to testimony from concerned citizens. Ed Siegfried, 22335 Albatross Circle, Jeremy Plaster, Hastings (step son to Ed Siegfried), Mike Conboy, 22285 Albatross Circle, Gene & Gretchen Schreiber, 22045 Albatross Circle, Bernie May, 22150 Albatross Circle, Bob Williams, 1278 220<sup>th</sup> Street, Gene Jahnz, 1328 220<sup>th</sup> Street, Cliff Salmon, 22125 Albatross Circle, and Michael Kiefer, 22320 Albatross Circle gave testimony to the condition of the possibility of a hazardous dump at 22355 Albatross Circle. Carolyn Kiefer stated the Board should deny the request for local zoning code and the Dakota County ordinance states the property owner is responsible for clean up of the property. Arlyn Lamb asked why wells weren't tested. Gary Piphon made a statement regarding denial. Michael Kiefer discussed the County Commissioners meeting at which time they added on the 8<sup>th</sup> whereas statement to the county letter of support ordinance 1599. sub div 2. Braun Intertec testing was discussed.

**Gary Piphon made a motion and Arlyn Lamb seconded to have the Clerk send a letter to Cheyenne Drogsvold of Human Services stating the Township is withholding its approval or denial for the location for 22355 Albatross Circle, Farmington MN 55024. Motion carried 5 ayes.**

Gary Piphon read the letter that is to be reviewed by the Township lawyer and then sent to Larry Burzinski, Supervisor of Licensing Division of Human Services. **Gary Piphon made a motion and Mike Rademacher seconded to check if the letter to be sent to Cheyenne Drogsvold of Human Services is in time or if Mr. Burzinski's letter dated March 19, 2007, supercedes the date of Cheyenne's letter. Copies of the letter are to be sent to Cheyenne Drogsvold and Larry Burzinski. Motion carried 5 ayes.**

**TATE BUILDING PERMIT**

Tom and Cheri Tate want to build a new house on their parcel. The Township should check for recent flood plain documents. **Arlyn Lamb made a motion and Gary Piphio seconded to approve that Tom and Cheri Tate may go ahead with their building permit plans. Motion carried 5 ayes.**

**FOUNTAIN VALLEY COMPREHENSIVE PLAN**

**Mike Rademacher made a motion and Arlyn Lamb seconded to send a letter to senior planner, Patrick Boylan of Met Council regarding the Fountain Valley Golf Course composed by Gary Piphio. Motion carried 5 ayes.**

**ACCOUNTS RECEIVABLE COLLECTION PLAN**

Discussion of possible resolution to assist with bill collections in the future. **Arlyn Lamb made a motion and Mike Rademacher seconded to send a letter to attorney to review and put in the form of a resolution. Motion carried 5 ayes.**
