# CASTLE ROCK TOWNSHIP ANNUAL MEETING March 8, 2005

The Annual Meeting of the Township of Castle Rock was convened at the Town Hall at 8:15 p.m. on Tuesday, March 8, 2005. Maralee Rother, Clerk, called the meeting to order at 8:15 p.m. The Pledge of Allegiance was recited. The Clerk called for nominations for a moderator. Mark Wagenknecht made a motion and Mike Rademacher seconded to nominate John Day. Bill May was nominated but declined. There being no other nominations, the motion was carried for John Day as moderator.

The moderator asked for approval of the agenda. Interest rates were added under new business.

The minutes of the 2004 Annual Meeting were read. Russ Zellmer made a motion and Randy Becker seconded to approve the minutes of 2004 as written and read. Motion carried.

#### TREASURER'S REPORT

Treasurer Roger Randall gave a report for the year ended December 31, 2004. The Township's total income was \$387,727.16, and the total expenses were \$315,905.79, leaving a balance of \$71,821.37. The general report is listed on pages nine and ten in the annual packet. On pages eleven, twelve and thirteen of the annual packet is the details of the income and expenses. **Bill May made a motion and Mark Wagenknecht seconded to approve the Treasurer's report subject to audit. Motion carried.** 

### ROAD COMMITTEE REPORT

Ken Betzold, Chair of the Road Committee, gave a report of the road committee's suggestions and roadwork done in the township the past year. A detailed report is on page four of the 2004 Annual Report.

## **COMMUNICATIONS REPORT**

Maralee Rother gave a report for the Communications Committee. The Communication Committee compiles and publishes the Castle Rock Chronicle. A full report of members and their duties can be found on page six of the 2004 Annual Report.

#### PARKS REPORT

## BOARD OF SUPERVISORS REPORT

#### **CLERK REPORT**

Maralee Rother, Clerk gave a report regarding Township activities. ## **OLD BUSINESS**

There was a straw vote taken at the 2003 Annual Meeting regarding clustering, but no action was taken on the subject this past year.

#### **NEW BUSINESS**

Donations were discussed. In the past, donations were given to Rambling River Senior Center, CEEF and Randolph Area Historical Group for a total of \$1,150.00. Elaine Wikstrom made a motion and Ken Betzold seconded to make a line item of \$1,200.00 in the budget for donations. Norbert Kuhn made a motion and Jon Kuhn seconded to amend the motion to allow the donations if it is legal for the Township to donate. The motion was passed as amended.

#### LAND ACQUISITION FOR TOWN HALL

Roger Randall presented an illustration of possibly acquiring some land surrounding the Town Hall. Bill May made a motion and David Mumm seconded to select Option C (see attached copy) with the Board's authority of flexibility with the landowner to make a decision for purchase. David Mumm made a motion and Bill May seconded to amend the motion to give the Board authority to negotiate for property up to 125% of what was paid for the land per acre and to acquire no more than two acres. Motion carried as amended.

#### **NEIGHBOR WATCH**

It is the consensus of the group to have a meeting with the Sheriff and Joe Harris and discuss the status of protection in the Township.

#### **INTEREST RATES**

Discussion was held regarding the interest rates of the CD's the Township has. It is up to the board to put the monies in better rates. The feeling is to stay at the local banks.

#### **ANNEXATION**

Annexation was discussed. **Ken Betzold made a motion and David Mumm seconded** that the Township appoint a task force committee to see if the Township wants to change the exploring of zoning and to keep the Township. Motion carried.

Volunteers for a position on the task force committee were Ken Betzold, Mark Henry, Norbert Kuhn, Paul Irrthum, Mark Wagenknecht and David Mumm.

## PROPOSED LEVY CHANGE

Elaine Wikstrom made a motion and Ken Betzold seconded to change the proposed levy of gravel and crushing to \$46,000.00 from \$40,000.00 as proposed. Motion carried.

## 2005 BUDGET AND LEVY

Roger Randall, Treasurer, reviewed the proposed budget and levy for 2005, which was on page fourteen. Jim Ozmun made a motion and Joe May seconded to accept the \$250,000.00 levy. Motion carried.
