## **NEW BUSINESS:**

Application for Ag Building – Percy Scherbenske, 3140 220<sup>th</sup> St E

In reviewing the application, it was discovered that the parcel where the applicant intends to construct the new pole building is on a one-acre lot so cannot qualify as an Ag Building. Mr. Scherbenske owns additional surrounding acreage, but that property is in his business name and the small parcel is in his and his wife's personal names. There was discussion if the intended location could be moved to the other parcel, but he indicated that is not possible due to the existing fencing on that property which would be costly to move. It was explained that the building permit application will need to be processed as an accessory building since it is on the residential lot. Barbara Lang, Clerk, was instructed to contact MNSPECT to find out if engineered drawings would be required by MNSPECT, as the size of this building is less than 3,000 square feet.
